**Subject: Cancellation of University Entrance Test Outstation Centres (2012)**

In view of the inadequate number of candidates, following outstation Centres of the ensuing University Entrance Test (UET/PET), scheduled between 18<sup>th</sup> May 2012 to 06<sup>th</sup> June, 2012 are being cancelled on the dates mentioned against the same:

1. Chennai Centre for all days
2. Hyderabad Centre for 18<sup>th</sup>, 19<sup>th</sup>, 21<sup>st</sup> May, 24<sup>th</sup> to 28<sup>th</sup> May, 30<sup>th</sup> -31<sup>st</sup> May and 01<sup>st</sup> to 06<sup>th</sup> June 2012 may be cancelled.

Consequently, following provisions have been approved:

- (1) Candidates of Chennai Centre will be allotted Hyderabad Centre on the days when tests are conducted at Hyderabad or other Centre as per choice.
- (2) On the days when test will not be conducted at Hyderabad Centre also, the candidates who have opted for Chennai & Hyderabad Centre will be allotted other Centre as per their choice.

Following provisions have also been approved:

1. Candidates who have filled-up only one choice out of three and the test is not held on that day at that center will be given Varanasi center.
2. All candidates who have not given any choice for centre of test will be allotted Varanasi as test centre.
