Subject: Recommendations of the UACB dated 30.07.2014 related with the admissions-reg.

- a) The conditional admission policy be not restored. The PG admissions should go on as scheduled and without any relaxation in the requirement of documents as prescribed. However, following provisions be made for the current academic session only (for the
- b) The supplementary examination of the papers of 5th and 6th semester examinations of 2013-14 be conducted after 15th August 2014 and its results declared by 20th September 2014
- c) All such candidates who possess PET merit index not below the index of last admitted candidate in the concerned category in the concerned PG course and meet the minimum eligibility requirement by clearing the supplementary examination (or otherwise) may be admitted in the concerned PG programme by creating equal number of supernumerary seats in the concerned category for this year (2014-15) only. The last date for establishing minimum eligibility requirement for such candidates shall be 20th September 2014.
- The aforesaid relaxation shall be equally applicable on the candidates of the PG programmes who are pursuing their qualifying degree from the BHU as well as other Universities.
- e) The aforesaid relaxation shall not be available to the candidates of UG programmes (as the UG counseling is already over). However, keeping in view the peculiar situation faced this year, programmes contained in the UET Bulletin and have UG degree as minimum eligibility requirement (which are governed by the regulatory bodies [such as B.Ed., B.P.Ed, LL.B. (Hons)] be also covered under the instant special provision for the current academic session
- The relaxation will be available for the academic session 2014-15 due to reasons cited above. Accordingly, all 5th semester students of the UG programmes of the University during the academic session 2014-15 be individually and formally informed by the Dean of the concerned Faculty, of the University's decision regarding withdrawal of conditional admission policy, so that, recurrence of similar situation is avoided during the next year.
- It was further decided that all such candidates who were called for counseling be informed of the aforesaid decision of the University, as many of them due to non availability of results might not have come for counseling. Similarly, admission committees be also sensitised to inform the candidates about the aforesaid decision of the University.
