Banaras Hindu University

Minutes of the meeting of the Executive Council held at 12:30 p.m. on 26th September, 2017 at India International Centre, New Delhi.

At the outset, the Vice-Chancellor and Chairman of the Executive Council extended a warm welcome to the Hon'ble Members in the meeting of the Executive Council and expressed his gratitude to the members for their help and guidance.

The Agenda items were then taken up.

ECR 465 ITEM 1

CONSIDERED confirmation of Minutes of the Executive Council Meeting held on August 20, 2017.

The members perused the Minutes and resolved that the Minutes of the meeting dated 20.08.2017 of the Executive Council be confirmed.

RESOLVED THAT the Minutes of the Executive Council meeting held on August 20, 2017 as per Appendix-1 be confirmed.

ECR 466 ITEM 2

CONSIDERED the orders of the Vice-Chancellor regarding confirmation of teachers and Group 'A' Officers of the University.

The Executive Council noted that the appointment of teachers as well as Group 'A' Officers is made by the Executive Council on probation for one year and on successful completion of probation they are confirmed on their respective posts under the orders of the Vice-Chancellor who is authorized to do so by the Executive Council (ECR 29 of 1977). Due process of confirmation had been followed before passing order for confirmation of teachers and Group 'A' Officers of the university listed in Appendix-2 of the agenda.

RESOLVED THAT the orders of the Vice-Chancellor for confirmation of teachers and Group 'A' Officers of the University as per APPENDIX-2 of the Agenda, be approved.

ECR 467 ITEM 3

CONSIDERED the decisions of the Investment Committee for investing the funds of Banaras Hindu University during the period from 12.07.2017 to 23.08.2017.

RESOLVED THAT the decision of the Investment Committee for investing funds of Banaras Hindu University during the period from 12.07.2017 to 23.08.2017 as per APPENDIX-3 of the Agenda, be approved.

ECR 468 ITEM 4

CONSIDERED officiating pay for holding additional charge of the office of the Registrar to Dr. K.P. Upadhyay, Ex-Controller of Examinations.

RESOLVED THAT officiating pay for holding additional charge of the office of the office of the Registrar from 06.09.2014 to 31.01.2017 to Dr. K.P. Upadhyay, Ex-Controller of Examinations, be approved.

ECR 469 ITEM 5

CONSIDERED the orders dated 10.05.2017 of the Vice-Chancellor for preparation of Post Based Rosters in respect of all levels of teaching posts by treating department/subject as a 'Unit' in terms of the order of Hon'ble High Court of Allahabad.

The Executive Council noted that the Rosters for teaching positions were prepared by the University cadre wise in terms of the guidelines of the UGC dated letter No. F.1-8/2006(SCT) dated 19th February, 2008 in this regard. The vacancies were accordingly being advertised as per the aforementioned Roster points. The advertisement No. 02/2016-17 was challenged

before the Hon'ble High Court of Allahabad and the Hon'ble High Court vide its judgment dated 07.04.2017 inter alia passed the following orders:

"Accordingly the writ petition succeeds and is allowed. The impugned Rolling Advertisement No. 02/2016-2017, in so far as it related to the teaching posts is quashed. Any appointments on teaching posts made pursuant to the said advertisement are also quashed. We also quash Clause 6(c) and 8(a)(v) of the Guidelines framed by the UGC and circulated vide covering letter dated 25.08.2006 and also its letter dated 19.02.2008.

Further we direct the respondent University to carry out the exercise of applying the reservation to the posts under advertisement treating the department/subject as a 'Unit' for all levels of teachers and thereafter publish the fresh advertisement and then proceed for selection and appointment".

Accordingly the University prepared the Rosters for teaching positions subject/department wise which have been checked and verified by the Liaison Officer and approved by the Standing Committee on SC/ST of the University. Aforesaid position was also informed to the UGC. A SLP No. 16515/2017 against the aforesaid decision of the Hon'ble High Court was also filed before the Hon'ble Supreme Court and the Hon'ble Supreme Court vide its judgment dated 21.07.2017 passed the following orders:

XXX XXX XXX

We do not find any ground to interfere with the impugned order except to direct that candidates who were in general category and already appointed will not be disturbed. The remaining vacancies as well

as the reserved vacancies may be filled up in accordance with the impugned judgment.

The special leave petitions accordingly disposed of.

Pending applications, if any, shall also stand disposed of.

In the light of the above, the Executive Council decided to approve the Rosters for teaching posts prepared subject/department wise in accordance with the judgment of Hon'ble High Court of Allahabad.

RESOLVED THAT the orders dated 10.05.2017 of the Vice-Chancellor for preparation of Post Based Rosters in respect of all levels of teaching posts by treating department/subject as a 'Unit' in terms of the order of Hon'ble High Court of Allahabad, be approved.

ECR 470 ITEM 6

CONSIDERED the orders of the Vice-Chancellor, BHU dated 18.07.2016 and 12.05.2017 for issuing advertisements and extending the cut-off date for receipt of on-line application under rolling advertisements.

RESOLVED THAT the orders of the Vice-Chancellor, BHU dated 18.07.2016 and 12.05.2017 for issuing advertisements and extending the cut-off date for receipt of on-line application under rolling advertisements, be approved.

ECR 471 ITEM 7

CONSIDERED the approval of recommendation of Selection Committees for appointment of teachers, promotion of teachers under CAS, re-employment of teachers and appointment of Group A non-teaching officers and on school teaching positions of the University.

The Executive Council was informed that in addition to the enclosed list of selection committees till 25.09.2017 in agenda, the meetings of the selection committees were also held for direct appointment in the Faculty of SVDV, Chairs, Medical Superintendent, SSH, IMS and for promotion of teachers under CAS in the Faculties of Management, Arts, Social Sciences and Agriculture. The recommendations of Selection Committees kept in sealed covers were placed on the table. Email dated 02.09.2017 of Dr. Kishor Patwardhan, Head, Department of Kriya-Sharir, Faculty of Ayurveda was also placed. The Executive Council also noted that writ petition/PIL have been filed before the Hon'ble High Court of Allahabad challenging the eligibility of some candidates who appeared for interview for the post of Medical Superintendent, Sir Sunderlal Hospital on various grounds. The Executive Council was of the view that under the circumstances it would not be appropriate to open the envelope containing the recommendation of the selection committee for appointment to the post of Medical Superintendent, Sir Sunderlal Hospital, BHU and the post be re-advertised.

RESOLVED THAT the recommendations of Selection Committees for appointment of teachers, promotion of teachers under CAS, re-employment of teachers, for school teaching positions and of Group A non-teaching officers except Medical Superintendent SSH be approved as per APPENDIX-7 of the Minutes.

RESOLVED Further that the envelope containing the recommendation of the selection committee for appointment to the post of Medical Superintendent, Sir Sunderlal Hospital, BHU be not opened and the post be re-advertised.

ECR 476 ITEM 12

CONSIDERED the request of Justice Giridhar Malaviya for donating a house building No. 579, ward 5, Badi Mata ki Gali, Imali Mahadev, Mirzapur to the Banaras Hindu University.

The Executive Council noted that Justice Giridhar Malaviya has made a request to the Vice-Chancellor that he along with his three brothers Shri Shashidhar Malaviya, Shri Premdhar Malaviya and Shri Shashidhar Malaviya wish to donate the building No. 579, ward 5, Badi Mata ki Gali, Imali Mahadev, Mirzapur whose only successor was Smt. Kundan Deviji, wife of Pt. Mahamana Madan Mohan Malaviya. Malaviya ji had registered the aforesaid asset to the family members of his son. The members of the Executive Council went through the letter dated 20 July, 2016 of Justice Giridhar Malaviya and resolved as under:

RESOLVED THAT the request of Justice Giridhar Malaviya for donating a house building No. 579, ward 5, Badi Mata ki Gali, Imali Mahadev, Mirzapur to Banaras Hindu University, be accepted in principle and the house be taken over by following the due process of law.

RESOLVED FURTHER THAT due acknowledgement of the donation with a letter of thanks, be sent to Justice Giridhar Malaviya.

ECR 477 ITEM 13

CONSIDERED merger of Indian Institute of Carpet Technology, Bhadohi with Banaras Hindu University, Varanasi.

The Executive Council noted that the Director, Indian Institute of Carpet Technology (IICT), Bhadohi, under the aegis of Development Commissioner (Handicrafts), Ministry of Textiles, Govt. of India, presently affiliated with APJAKTU, Lucknow & approved by AICTE, Govt. of India, vide its letter No.R/Admn/Merger/152/IICT/2017/613 dated August 31, 2017, addressed to the Registrar, Banaras Hindu University, informed *inter alia*, that as conveyed by the Development

Commissioner (Handicrafts), Govt. of India, Ministry of Textiles vide its D.O. letter No. 1-11020/42/2017-18/IICT-Merger/751 dated 28.08.2017, the competent cabinet in the Ministry of Textiles, Government of India "in principle" approved the merger of IICT with BHU thereby making the former a campus of the latter.

The referred to letter dated 28.8.2017 of the Development Commissioner (Handicrafts), Ministry of Textiles, further mentions that as the merger involves transfer of assets (movable and immovable) and human resources, the terms of merger are to be laid down in advance so that the connect of the IICT with the stakeholders do not get disturbed after the proposed merger. The communication also informs that for working out the details of the merger, a committee of the following members has been constituted:

- 1. The Additional Secretary Chairperson
- 2. The Development Commissioner (HC) Member (Convener)
- 3. The Director, Indian Institute of Carpet Technology Member
- 4. The Chairperson, CEPC Member
- 5. The Registrar, BHU Member

The referred to letter dated 28.8.2017 of the Development Commissioner (Handicrafts), Ministry of Textiles, also gives direction to proceed accordingly, in the mean time, to finalize the prerequisite issues in consultation with the Director, IICT, Bhadohi and submit the same in the form of agenda. However, a meeting is to be convened shortly by the Ministry for working out the details of the proposed merger based on the submission of the agenda from BHU.

In the mean time, the aforesaid IICT, Bhadohi vide its referred to letter dated August 31, 2017 has also sent a detailed note highlighting the following prerequisite issues identified by the IICT for dealing appropriately by the University to ensure smooth merger without any disturbance:

- 1. Transfer of assets (movable and immovable);
- 2. Transfer of human resources (regular and outsourced);
- 3. Connect of IICT with stakeholders, viz. Students, Industry and Statutory Bodies;
- 4. Service rule of IICT;
- 5. Nomination, Notification and Publicity; and
- 6. Issues to be identified by BHU

The Executive Council noted the provisions of the Act and Statute of Banaras Hindu University. It also noted that the University is an autonomous institution in the Ministry of Human Resource Development, Government of India and receives fund through UGC for running its affairs. Since the competent cabinet of Ministry of Textiles, Government of India has already decided the merger of IICT, Bhadohi with Banaras Hindu University making former an integral part of the latter and since the merger would involve transfer of assets, human resource and other liabilities of IICT to BHU which would entail recurring and non-recurring liabilities on the University, hence it would be appropriate to obtain the concurrence of MHRD/UGC on the aforesaid decision of merger of IICT with BHU.

The Executive Council deliberated over the entire issue in detail in the light of the decision of the competent cabinet of the Ministry of Textiles, Government of India for merger of IICT, Bhadohi with Banaras Hindu University and the

provisions of the Acts and Statutes of Banaras Hindu University and decided to grant in principle approval of the same with the concurrence of MHRD and resolved as under:

RESOLVED THAT decision of the competent cabinet of the Ministry of Textiles, Government of India for merger of IICT, Bhadohi with Banaras Hindu University making the former a campus of the latter, be approved "in principle".

RESOLVED FURTHER THAT the concurrence of the MHRD for the aforesaid decision be also obtained.

RESOLVED STILL FURTHER THAT since the merger involves transfer of asset and liabilities of IICT, Bhadohi to BHU on its merger, the representatives of MHRD and UGC be also included in the committee constituted for working out the details of the merger, if the MHRD gives its concurrence of the merger.

ECR 478 ITEM 14

CONSIDERED the recommendations of RAAC for reviewing the provision of counting of previous services rendered by an employee elsewhere prior to joining BHU for the purpose of determining seniority of allotment of accommodation in the University.

RESOLVED THAT the recommendation of RAAC in its meeting held on 09.12.2016, be approved.

ECR 479 ITEM 15

CONSIDERED nomination of three members to the Senate of IIT (BHU).

RESOLVED THAT the Vice- Chancellor be authorized to nominate members of the senate

of IIT(BHU) for the period of one year in terms of the provisions contained in section 9 of the Institute of Technology (Amendment Act) 2012.

ECR 480 ITEM 16

CONSIDERED the proposal for establishment of Mahamana Pt. Madan Mohan Malviya Cancer Centre at Banaras Hindu University.

The Executive Council noted that following the decision for establishing a State of Art Cancer Centre at BHU, Varanasi taken in the meeting held at PMO, New Delhi on 19.12.2016, the University has received a draft MoU from the Department of Atomic Energy, Tata Memorial Centre (TMC), Mumbai vide email dated 19.12.2016 proposed to be signed between TMC and BHU for establishing a new Cancer Centre at BHU. The University vide its letter dated 19.12.2016 made clear its views to the Prime Minister's office New Delhi that the proposed cancer centre should be created as a facility of DAE in IMS under academic and administrative control of BHU having functional and financial autonomy. It may be run by the IMS with strict adherence to the norms, system and protocols of TMC under its supervision. The University agreed to consider making necessary changes in statutory provisions to facilitate this arrangement and ensured that the standards of TMC would strictly and scrupulously be followed. Accordingly it was requested to consider reconstructing the proposed MoU on the above lines. Agreeing to the request of the University, the PMO vide its email dated 21.12.2016 has sent revised final draft of the MoU to be signed by the TMC and BHU for Cancer Centre which was agreed and signed. As per MoU the centre would be named as Pt. Mahamana Madan

Mohan Malaviya Cancer Centre and BHU would earmark a land parcel of 10 acres at Sunderbagia for the said Cancer Centre. The announcement of the establishment of said Mahamana Pt. Madan Mohan Malaviya Cancer Centre at BHU was made by Hon'ble Prime Minister on 22.12.2016 in a function held at Swatantrata Bhawan, BHU.

Subsequently it was decided in the meeting chaired by the Principal Secretary to Prime Minister which was held on 14th September 2017 that a land parcel of 15 acres instead of 10 acres be earmarked for the Cancer Centre and accordingly the MoU signed between BHU and DoAE-TMC be amended. The University has agreed to this.

It was also decided in the meeting that since the Tata Trust has offered to construct the Cancer Centre with its own resources and hand it over to DoAE (TMC), a tripartite agreement among DoAE-TMC, TATA Trust and BHU be signed.

Accordingly TMC has sent a draft of tripartite MoU to BHU for approval which after due deliberation and approval of Vice-Chancellor, was suitably modified and sent to TMC.

TMC agreed to the suggestions of the University and final tripartite agreement has been signed.

After detailed consideration and deliberation over the matter and taking into account the aforesaid facts of establishment of Mahamana Pt. Madan Mohan Malaviya Cancer Centre at Banaras Hindu University, the Executive Council resolved as under:

RESOLVED THAT the proposal for establishment of Mahamana Pt. Madan Mohan Malaviya Cancer Centre at Banaras Hindu University as per the decision taken in the meeting held on 19th December, 2016 at PMO, and consequently the MoU signed between BHU and Department of Atomic Energy, Tata Memorial Centre, be approved.

RESOLVED FURTHER THAT the tripartite MoU signed between BHU, Department of Atomic Energy, TMC and Tata Trust as per the decision taken in the meeting held on 14.09.2017 at PMO, be also approved.

ECR 481 ITEM 17

CONSIDERED designating Shri V.K. Upadhyay, Sr. Advocate, Hon'ble High Court, Allahabad and Sr. Standing Counsel of the University as Legal Advisor.

RESOLVED THAT Shri V.K. Upadhyay, Sr. Advocate, High Court, Allahabad and Sr. Standing Counsel of the University be designated as Legal Advisor initially for a period of three years on a fee as per GOI norms. He will advise the University on all legal, administrative and other matters.

The Vice-Chancellor informed the Executive Council that a scheme of appointment of Centennial Chair Professor in Bharat Adhyayan Kendra for a period of one to five years was approved by the Executive Council. Accordingly persons have been appointed on the Chairs initially for a period of two years

extendable for further period. The Chair Professors have undertaken the work in their respective areas related to the objectives of Bharat Adhyayan Kendra which is progressing satisfactorily. Now for the completion of the assigned work in Bharat Adhyayan Kendra for realization of its objectives, the continuity of persons appointed on Chairs is necessary. The Executive Council agreed to the proposal of the Vice-Chancellor and resolved as under:
