TO CONSIDER counting past service for promotional avenues of Vaidya Sushil Kumar Dubey, Assistant Professor, Department of Kriyasharir, Faculty of Ayurveda, Institute of Medical Sciences, BHU.

NOTE

Vidya Sushil Kumar Dubey joined the Banaras Hindu University on 10.10.2017 as Assistant Professor in Department of Kriyasharir, Faculty of Ayurveda, Institute of Medical Sciences, BHU. Before joining the University, Vidya Sushil Kumar Dubey aforesaid had rendered his services as Lecturer in Uttar Pradesh Government from 27.01.2009 to 09.10.2017. Vidya Sushil Kumar Dubey vide letter dated 06.04.2021 has requested for consideration of his date of eligibility as Assistant Professor (Stage-3) by counting past services rendered as Assistant Professor (Stage-1) without being promoted to the post of Assistant Professor (Stage 2) in his previous organization, on the basis of letter No. F.2-1/2006(PS)Misc dated 27.09.2006 (**Annexure-13A**). In this connection, a clarification vide letter No. AB/14-L-1152/23192 dated 03.02.2021 (**Annexure-13B**), was sought from University Grant Commission on the aforesaid issue so as to enable this University to determine the date of eligibility of Vidya Sushil Kumar Dubey on the post of Assistant Professor (Stage-3) by counting past services rendered as Assistant Professor (Stage-1) only, for more than 09 years. In response the UGC vide letter No. 9-20/2020(PS) dated 23.02.2021 (**Annexure-13C**) has informed that the appointment of the candidate governed by UGC Regulations, 2010 clearly states that for promotion from stage-2 to stage -3 requires 5 years of service, either in the present service or by counting past service in stage-2.

The Executive Council may kindly consider and decide.



However, CAS is applicable w.e.f. 27.7.98.



Subject: Seeking clarification on the issue of deciding date of eligibility upon promotion under CAS by counting of past service in terms of letter no. F.2-1/2006(PS)Misc dated 27.09.2006 of the UGC - reg.

Sir,

With reference to the subject cited above, your kind attention is drawn towards the letter no. F.2-1/2006(PS)Misc dated 27.09.2006 of the UGC, whereby it was clarified that a teacher holding Ph.D. degree can be considered for promotion to the post of Reader under CAS, if he/she has completed five years of regular service as Lecturer (Sr. Scale) or nine years as Lecturer / Lecturer (Sr. Scale) and fulfils all other conditions for CAS (*copy enclosed for ready reference*).

While determining the date of eligibility of a faculty member upon his promotion under CAS, who joined this University in the year 2017 as Assistant Professor (Stage-1), it is observed that he had completed 09 years or more services in his previous institution as Lecturer/Assistant Professor but was not promoted as Lecturer (Sr. Scale) / Assistant Professor (Stage-2) either under UGC Regulations, 2010 or 2018.

The Faculty Member is now claiming for consideration of his date of eligibility as Assistant Professor (Stage-3) by counting his past services rendered as Assistant Professor (Stage-1) without being promoted to the post of Assistant Professor (Stage 2) in his previous organization, on the basis of aforesaid letter dated 27.09.2006.

Pertinent to mention that the designation of Reader, with less than 03 years of service, has been replaced with the Assistant Professor (Stage 3) in AGP Rs.8000/-, and it seems that the aforesaid letter dated 27.09.2006 was issued with reference to the UGC Regulations 1998. However, no guideline is available as to whether the aforesaid rule is still applicable in subsequent UGC Regulations, 2010 and 2018 respectively or not.

In view of the above, I am directed to seek clarification on the aforesaid issue, so as to enable this University to determine his date of eligibility on the post of Assistant Professor (Stage-3) by counting past services rendered as Assistant Professor (Stage-1) only, for more than 09 years.

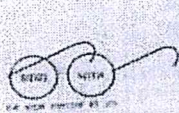
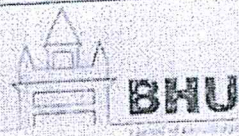

ITEM 14

TO CONSIDER AND DECIDE the observation of the then Internal Audit Officer in reference to the effective date of promotion of Non Teaching Staff in the meeting of Departmental Promotion Committee held on 07.11.2020.

NOTE

In reference to the promotion of Non Teaching Staff, the Executive Council vide Resolution No.131 (11) dated March 29-30,1996 resolved as under:

"Departmental Promotion Committee be held at least twice a year so that promotion to the in-service employees be given from the date of their eligibility, subject to availability of vacant positions or from the date of vacancy".

Further, the Appointments Committee vide its resolution No.120 dated 01/10/1996 modified this provision and resolved as under:-

"promotions will be effective from the date of the meeting of D.P.C. or from the date of vacancy whichever is later, as per rule."

Subsequent upon the said decision of the Appointments Committee, it was observed that Departmental Promotion Committee could not meet timely even after availability of vacancy, as a result eligible candidates were deprived of timely promotion.

In accordance with the decision of the Executive Council Resolution No.131(11) dated March 29-30,1996 the Administration had emphasized convening timely meetings of Departmental Promotion Committee, in respect of the Group 'B','C' & 'D' category, but after several attempts by the administration even after availability of vacancy the same could not materialize.

The Non-Teaching Staff Grievance Committee in its meeting held on 26.08.2013 considered the representations of staffs for giving promotions to the non-teaching staff from the date of eligibility or from the date of occurrence of vacancy whichever is later, as per Government of India rules for cadre based promotions and resolved to recommend as under:-

*"Ms. Anuradha & Shrii Ajit Kumar Jaiswal be given their due promotion from the date of eligibility or from the date of occurrence of vacancy, whichever is later, as per Government of India rules for cadre based promotions. Further, **all the subsequent D.P.C. meetings held after May,1998 be also reviewed and the promotions be given to the eligible employees from the date of eligibility or from the date of occurrence of vacancy, whichever is later, as per Government of India rules for cadre based promotions. Such promotions be given on or after 09/08/1999 i.e. the date of implementation of ACP Scheme.**"*

The Vice Chancellor by considering the fact that inspite of several directives issued from the Central Registry, regular meeting of the DPCs are not convened and the Non teaching staffs are deprived of timely promotion, approved the aforesaid recommendation and the same was placed in the meeting of Executive Council.

The Executive Council vide Resolution no. 179 dated 05.02.2014 resolved as under:-

RESOLVED THAT the order of the Vice-Chancellor approving the recommendation of the ***Departmental Promotion Committee of the Central Registry for effecting promotions to the non-teaching staff from the date of eligibility and availability of vacancy***, and reviewing all the concerned DPC held after May,1998 for giving promotion to the eligible employee within the cadre, on or after 09/08/1999 (i.e. the date of implementation of A.C.P. Scheme),be approved.

Later, the then Internal Audit Officer in the meeting of Departmental Promotion Committee held on 07.11.2020 discussed in depth in terms of the decision of the Executive Council, by which benefit of promotion is extended from the date of eligibility subject to availability of vacancy and gave his observation as under:

'After perusal of agenda for the Departmental Promotion Committee of Central Registry, it was revealed that promotions were proposed from the date of eligibility or from the date of vacancy, whichever is later. Backdated promotion is not in consonance with FR 17(1) and para 6.4.4 of the DoPT OM dated 10th April, 1989. Hence, it is not admissible. Member Secretary, Joint Registrar (Admin.-NT) stated that it was as per minutes of EC Committee. Undersigned as IAO of the University brought the attention of Registrar and Chairman of the Committee regarding UGC Communication dated May 1, 2018 addressed to the Registrar of all Central Universities to follow the GFR 2017 as circulated by the UGC vide letter No.13-2/2017(CU) dated 27th May, 2017 and ensure the instructions of MHRD as articulated in

the guidelines for financial management in the Central Universities and procedure to maintain financial propriety and no deviation from the procedure be allowed as circulated by MHRD vide letter No.F No.61-19/2015-Desk(U) dated March 3, 2016. Further, MHRD communication dated March 3, 2016 was to the Chairman, UGC about improving financial management and strict compliance of rules/procedures in the Central Universities e.g. in administrative matters like Career Advancement Scheme, promotion policies, fixation of pay/grade pay, allowances, increments, upgrading/revision of pay scales/allowances etc. decision must be taken in strict conformity with the rules/regulations/instructions of Government of India/UGC, failing which strict disciplinary action will be taken against the responsible officials. The same was to be ensured by the Finance Officer and the Registrar of the University. Registrar stated the matter would be taken to EC for decision. As IAO undersigned suggested to take prior approval/consent of the UGC before taking the matter to EC as envisaged in para(2) of the letter dated March 3, 2016.'

The Executive Council may consider and decide.

ITEM 15

TO CONSIDER AND APPROVE amendment in the validity period of advertisement as 06 months instead of prevailing validity period of two years & 18 months as decided vide ECR No. 112 dated November 3-5, 1995 & Ordinance 11.A.2 respectively and validity period of panel/waitlist as 01 years instead of 02 years as decided vide ECR No. 112 dated November 3-5, 1995 for non-teaching posts.

NOTE

The University Grants Commission, New Delhi vide its letter No.F.74-1/2017 (CU) dated 16th October, 2017 has forwarded O.M.No.Misc.14017/15/2015-Estt. (RR) dated 11.01.2016 of DoPT regarding time limit for holding examinations / interviews from the date of advertisement for the post under direct recruitment.

(Annexure-15A)

The DoPT vide its O.M. No. Misc.14017/15/2015-Estt. (RR) dated 11.01.2016 has given following directives for compliance:

“

2. All Ministries / Departments are, therefore, requested that while initiating the recruitment process to fill vacant posts(s) by the method of direct recruitment in their Ministries / Departments, it may be ensured that the entire recruitment process including and starting from advertisement, conducting written examination or holding of interview may be completed within six months.

3. The administrative Ministries / Departments may issue similar instructions to autonomous bodies / PSUs / statutory bodies under their administrative control.”

The Executive Council vide its ECR No. 112 dated November 3-5, 1995 has earlier decided the validity period of advertisement and panel prepared by the Selection Committee for all cadre of posts and resolved as under: **(Annexure-15B)**

“RESOLVED that the period of validity of advertisement will be two years for all categories of posts.

RESOLVED further that the period of validity of panels of candidates recommended for appointment by the Central Board of Recruitment etc. will be two years from the dated of declaration of the panel."

Further, the Ordinance 11.A.2 prescribes the following regarding validity of advertisement for all vacant non-teaching posts of permanent nature, plan posts, the posts temporary likely to continue carrying pay scale of Rs. 15600-39100 and above: **(Annexure-15C)**

Further, provided that the period of validity of newspaper advertisements will be 01 year for all category of posts.

(c) Where Selection Committee has not met, even after a lapse of 18 months after advertising the post, the post will be re-advertised.

Provided that if in the opinion of the Vice-Chancellor the circumstances so necessitate he may extend the validity of the advertisement upto 24 months after expiry of the last date of receipt of applications."

In compliance of above O.M. No.Misc.14017/15/2015-Estt. (RR) dated 11.01.2016 of DoPT the following amendments in the ECR No. 112 dated November 3-5, 1995 and Ordinance 11.A.2 are required :

Subject: Instructions regarding time limit for holding examinations / interviews from the date of advertisement for the post under direct recruitment – reg.

The undersigned is directed to refer to the subject and to say that it has come to notice of this Department that there are instances of a long time lag between the date of advertisement for the vacancy and date of examination or interview. This delay may deny the opportunity to fresh candidates who become eligible during that period, while creating an atmosphere of uncertainty to candidates who have applied. .

2. All Ministries / Departments are, therefore, requested that while initiating the recruitment process to fill vacant posts(s) by the method of direct recruitment in their Ministries / Departments, it may be ensured that the entire recruitment process including and starting from advertisement, conducting written examination or holding of interview may be completed within six months.

3. The administrative Ministries / Departments may issue similar instructions to autonomous bodies / PSUs / statutory bodies under their administrative control.

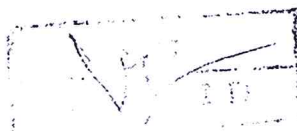

RESOLVED further that the period of validity of panels of candidates recommended for appointment by the Central Board of Recruitment etc. will be two years from the date of declaration of the panel.

Ordinance 11A

11.A.2. ORDINANCE GOVERNING THE PROCEDURE TO BE FOLLOWED BY THE SELECTION COMMITTEE IN MAKING RECOMMENDATIONS FOR APPOINTMENT AGAINST THE POSTS OF REGISTRAR, CONTROLLER OF EXAMINATIONS AND LIBRARIAN UNDER THE PROVISION OF STATUTE 27(2) OF THE BHU ACT AND STATUTES AND OTHER NON-TEACHING POSTS

1. Advertisement and inviting of Applications :

(a) All vacant Non-teaching posts of permanent nature, plan posts, the posts temporary likely to continue carrying pay scales of Rs.15600-39100 and above shall be advertised, giving two insertions in National Dailies and one insertion in the local daily. Only essential details of the post and pay scale shall be indicated in the advertisement. The detailed advertisement shall be placed on the BHU Website and will be published in Employment News. The requirement of publishing in Employment news may be waived off in case of urgency under the orders of Vice-Chancellor. Individuals desirous of offering their candidature for a given post may obtain the prescribed application form and particulars of qualification etc. from the Website.

Further provided that the period of validity of newspaper advertisements will be 1 year for all category of posts.

(b) Temporary Leave vacancy posts of full-time or part-time shall ordinarily not be advertised but filled in by appointing temporary persons on a full-time or part-time basis from a panel approved by the Executive Council on the recommendation of the Statutory Selection Committee, under Section 27 of the BHU Statutes.

Provided that if a panel is not available, the post shall be advertised for convening meetings of the Statutory Selection Committee to make recommendations.

(c) Where Selection Committee has not met, even after a lapse of 18 months after advertising the post, the post will be re-advertised.

Provided that if in the opinion of the Vice-Chancellor the circumstances so necessitate he may extend the validity of the advertisement upto 24 months after expiry of the last date of receipt of applications.

(d) The last date for receipt of applications shall ordinarily be two months from the date of issue of the advertisement. The last date shall be clearly specified and applications received after the expiry of the last date shall not be entertained.

(e) Advertisement shall stipulate the number of likely vacancies to be filled in with a provision that the vacancies may increase by the time the Selection Committee meets to interview candidates.

(f).(i) Applications for all the posts shall be entertained only on the prescribed application forms, accompanied by a Bank Draft/Indian Postal Order/Overseas Postal Order for amounts as are fixed from time to time, by the

Executive Council. The Bank Draft/Indian Postal Order/Overseas Postal Order shall be made out in favour of the Registrar, Banaras Hindu University .

Money Orders or Cheques shall not be accepted towards application fee.

- (ii) Permanent employee of the University (including those on probation) may be exempted from payment of application fee.
- (g)(i) The schedule of charges for the application forms and prescribed fees shall be as determined by the Executive Council from time to time.
- (ii) The application forms shall be made available on the University website for free download.
- (iii) Candidates desirous of obtaining application forms and particulars by post are required to apply for the same in writing, enclosing :
 - a). Self-addressed envelope of 23cm/10 cm size;
 - b). Bank Draft/IPO/Overseas Postal Order in favour of the Registrar, Banaras Hindu University to cover the cost of application fee and registration charges as prescribed from time to time.
 - c). Forms shall be available for sale on working days at the Selection Committee Section from 10.30 hrs. to 14.30 hrs.
- (h) Applications received in the office shall be entered in the Application Register prescribed for the purpose and acknowledged.

2. Nomination of Expert Members to serve on Selection Committee

- a). The Vice-Chancellor shall prepare the list of expert members for various posts which have been advertised, and place the same before the Executive Council for approval.
- b). The Vice-Chancellor shall ordinarily invite experts for attending the meeting of a Selection Committee from the panel approved by the Executive Council provided that in the event of special urgency the Vice-Chancellor may make additions to the panel to attend the Selection Committee and report the names of members added to the Executive Council alongwith the minutes of the Selection Committee.

3. Short-listing of candidates for interview:

- a). Short-listing of applications for inviting candidates for interview for appointment against the post shall be done by a Committee.

ITEM 16

TO CONSIDER the matter of proper utilization of Shimla Property of Banaras Hindu University.

NOTE

A land with a house constructed on it known as Assam House situated at Boileauganj, Shimla was donated by one Shri Bola Nath Barooah of Assam on 25.11.1921. The measurement of the land and the house is 5721 sq yard. The following were the terms and conditions on which the donation was made:

Background of the property

The Banaras Hindu University owns two adjoining properties at Boileauganj (near the Indian Institute of Advanced Studies) in Shimla.

- (a) Barooah Assam House, east covering an area of 5721 sq. yards.
- (b) An open land covering an area of 403 sq. yard and 5 sq. feet adjoining the Assam House Estate, Boileauganj obtained by the University through a sale deed from the Governor of Punjab on 27th July, 1940.

For all purposes the two properties are considered together as a single entity measuring 5132.69 sq. metres.

The Barooah Assam House was donated by Shri Bholanath Barooah on 25th November, 1921 on the following terms conditions:

- i) That the name of the property shall forever be retained as "Barooah Assam House."
- ii) That the grantee (BHU) shall not for all times to come sell the said premises which shall be forever hereafter held in trust for the purpose herein after mentioned in deed. The grantee shall hold the premises upon following trusts:
 - a) A portion shall be used for the purpose of accommodation of Vice-Chancellor or other members of the University who might go to Shimla and also scholars of the University who might be sent to Shimla.

- b) The remaining portion shall be let out on rent provided always during the life time of the Granter two bed rooms attached in the middle flat will be reserved for the accommodation of the Granter and his friends who might go to Shimla.
- c) Out of the rent derived from letting out the said premises, all outgoings including the cost of repairs and salaries of one chowkidar and mali who shall be appointed to take care of the said premises shall be met out and out of the balance a Gold Medal for value of Rs. 100/- and not more than Rs.150/- shall be awarded every year to the student who stands first in the examination of the degree of Mech. Engineering of the University. The medal shall be called "Prince of Wales Gold Medal."
- d) Out of the remaining income scholarship of Rs. 50/- per month to be called "Bhola Nath Barooah scholarship" tenable for 4 years shall be awarded once in 2 years to Assamese student who having obtained highest mark in the I.sc. examination from the Cotton College, Guwahati or to the best Assamese student who may join BHU for the purpose of studying Mech. Engg. or Mining Engg. The balance of the income of the property shall be devoted to general objects of the University.
- e) It is hereby declared that should the said Banaras Hindu University cease to exist then this deed shall be null and void and property shall belong to the granter or his heirs, legatees or legal representatives.

Subsequently the adjoining land measuring 403 sq. yard and 5 sq. feet was acquired by the University from the Government of Punjab in the year 27th July, 1940. Thus the total area of the land at present is 5132.69 sq.mt.

With the passage of time the main house collapsed however the annexes of the house remained which were inhabited by the tenants. At present the following tenants are residing in the building.

In the year 2007, a committee comprising Prof. Anand Mohan, Dr. S.D. Singh, Members of the then Executive Council, the Registrar, OSD Estates visited the property and met the tenants. After assessing the situation of the property, the committee recommended the following:

1. The tenants may be regularized with enhanced rents and may be shifted to any one pocket of land as eviction process is bound to consume a few years' time.
2. The construction of a Guest House and Study Centre may be taken up on priority basis either in collaboration with the state of Himachal Pradesh/Indian Institute of Advance Studies or independently by the University.
3. To begin with the possibilities of collaborations, space requirement, space availability for construction, maps of the buildings to be constructed with cost staff requirement, recurring and non-recurring expenditures may be worked out.

The report was placed in the meeting of the Executive Council held on 30.06.2007. The Executive Council resolved vide ECR No. 151 as under:

RESOLVED THAT the report submitted by the Hon'ble Members of the Executive Council on the BHU Property at Shimla be approved

Now, again the EC vide ECR No. 85 dated 01.03.2019 has constituted a committee consisting the following members of the Executive Council to address issues regarding a number of immovable properties in Varanasi as well as outside Varanasi:

1. Prof. Anand Mohan, Member, Executive Council, BHU
2. Prof. A.P. Pandey, Member, Executive Council, BHU
3. Prof. Bachchha Singh, Member, Executive Council, BHU
4. The Registrar, BHU
5. Dy. Registrar, Estate, Banaras Hindu University

The committee held its meetings for consideration of various issues involved in different estates property of the University and has taken up the issues related to the property situated in Varanasi with the District Administration and the District Administration has also shown interest in it by constituting a committee of concerned officers of the District Administration to look into the issues related to each property and submit its report. The matter is being followed up with the District Administration. As far as the legal issued is involved, the committee approached the Chancellor who is also a legal luminary and a former justice at High Court, Allahabad alongwith a senior standing counsel and the standing counsel of the University engaged in these cases.

After many rounds of deliberations with them, some head wave was made and the case was listed for hearing on the application of early hearing before the Hon'ble High Court. But because of non-regular sitting of the Court during this pandemic, the case could not come up for hearing before the Hon'ble High Court.

The issue related to the properties situated outside Varanasi were also deliberated by the Committee in its meeting and in one such property situated at Shimla, it was decided that the University must start some activity on this land in order to put it to use and save it from the unauthorized occupation/encroachments which it left unattended for long, will render it prone to encroachments. Accordingly the superintending Engineer of CPWD unit at Shimla who happens to be an alumnus of BHU, was approached to suggest for purposeful utilization of the property. He has suggested that a research centre with guest house facility and facilities for conferences / workshops would be useful for the University on this land. He has also sent the design and drawing of the proposed research centre cum convention center and guest house alongwith the estimated cost of construction as Rs.17 crores. The proposal was discussed by the committee constituted by the EC in its meeting held on 31.05.2021. It was noted that the proposed building is four storied (Ground + three) with foundation upto six stories for future expansion alongwith a provision of parking and the annexes for dwelling of the employees engaged for running the centre. After perusal of the design and drawing, the committee suggested some modification in it and resolved that the revised design alongwith the estimated cost be put up before the next meeting of the EC for its consideration and decision on the utilization of the property. Minutes of the meeting of the Committee and the drawing and design of the proposed building is enclosed as **Annexure-16**.

The Executive Council may kindly consider and decide.

A property of BHU is located in Shimla District of Himanchal Pradesh. Property measuring about 5132.69 sqm is situated at a prime location in Shimla, several encroachments have been made on this property with passage of time. Taking into consideration the above fact a subcommittee of Executive Council was constituted to look into the matter for exploring the possibilities of developing this property to safe guard it from encroachment and for its proper utilization. The Sub Committee of Executive Council of the university in its meeting held on 16/6/2020 resolved that the D.G CPWD/S.E CPWD, Shimla be requested to explore and provide the possibility of developing the property as a Guest House cum Research Activity Centre. In compliance of the above resolution, the Shimla unit of CPWD was approached and a letter was sent on 23.07.2020 to CPWD unit of Shimla for providing the architectural design and estimate for developing the property as a Guest House cum Research Activity Centre, accordingly they have submitted an architectural drawings and estimate for the same.

CONSIDERED the architectural design and map of proposed Guest house cum Research activity centre to be developed at the Boileauganj, Shimla, provided by the CPWD. UWD presented the detailed drawings of the proposed building before the committee. The committee considered the layout design of the proposed building and after the detailed discussion and deliberation.

THE COMMITTEE RESOLVED THAT:

Deliberating in detail, the **COMMITTEE RESOLVED** that the architectural design of proposed Guest House cum Research activity Centre provided by the CPWD Shimla be put up before the Executive Council along with the estimate for consideration after incorporating the following modification in the proposed layout plan.

Wing -A Ground Floor

- 1) Existing proposed Caretaker room to be shifted to Wing- B adjacent to the reception area, there is no need of two separate caretaker room for two wings.
- 2) Single dining hall to be provided for both wings. Dining hall area to be increased. As there is no need of two separate dining hall.
- 3) Proposed suite at ground floor be placed near to the entrance area.
- 4) Reception area will be single height.
- 5) There is no requirement of record room.
- 6) Kitchen to be placed at the location of the proposed caretaker room.
- 7) Proposed library at ground floor to be shifted on first floor, adjacent to the Conference/Meeting Hall.

Wing -A- First Floor

- 1) The proposed meeting hall and research activity hall to be merged as a single large size hall with provision of collapsible partition, in such a way, that on requirement this hall can be used as two separate halls with full functionality, as the proposed size of these two halls are not proper.
- 2) Research activity hall to be accommodated on the space just in front of Stairs by making the reception area slab as a single height slab.
- 3) Library to be placed just adjacent to the proposed meeting hall.

Wing -A- Second and Third floor

No change.

Wing -B Ground Floor

- 1) Existing proposed Caretaker room to be shifted to adjacent to the reception area for proper controlling and ease of access.
- 2) Area proposed for dining hall in this wing may be used for developing some more room. As there is no need of two separate dining hall.
- 3) A room and store to be provided for housekeeping staffs.
- 4) **Wing -A- First Floor, Second and Third floor**

No change.

Other modification suggested by the Committee

- 1) Both wing to be interconnected on first floor onwards, for ease of access.
- 2) A dormitory along with toilet facility is to be developed.



CONTOUR PLAN OF GUEST HOUSE FOR BANARAS HINDU UNIVERSITY, SHIMLA

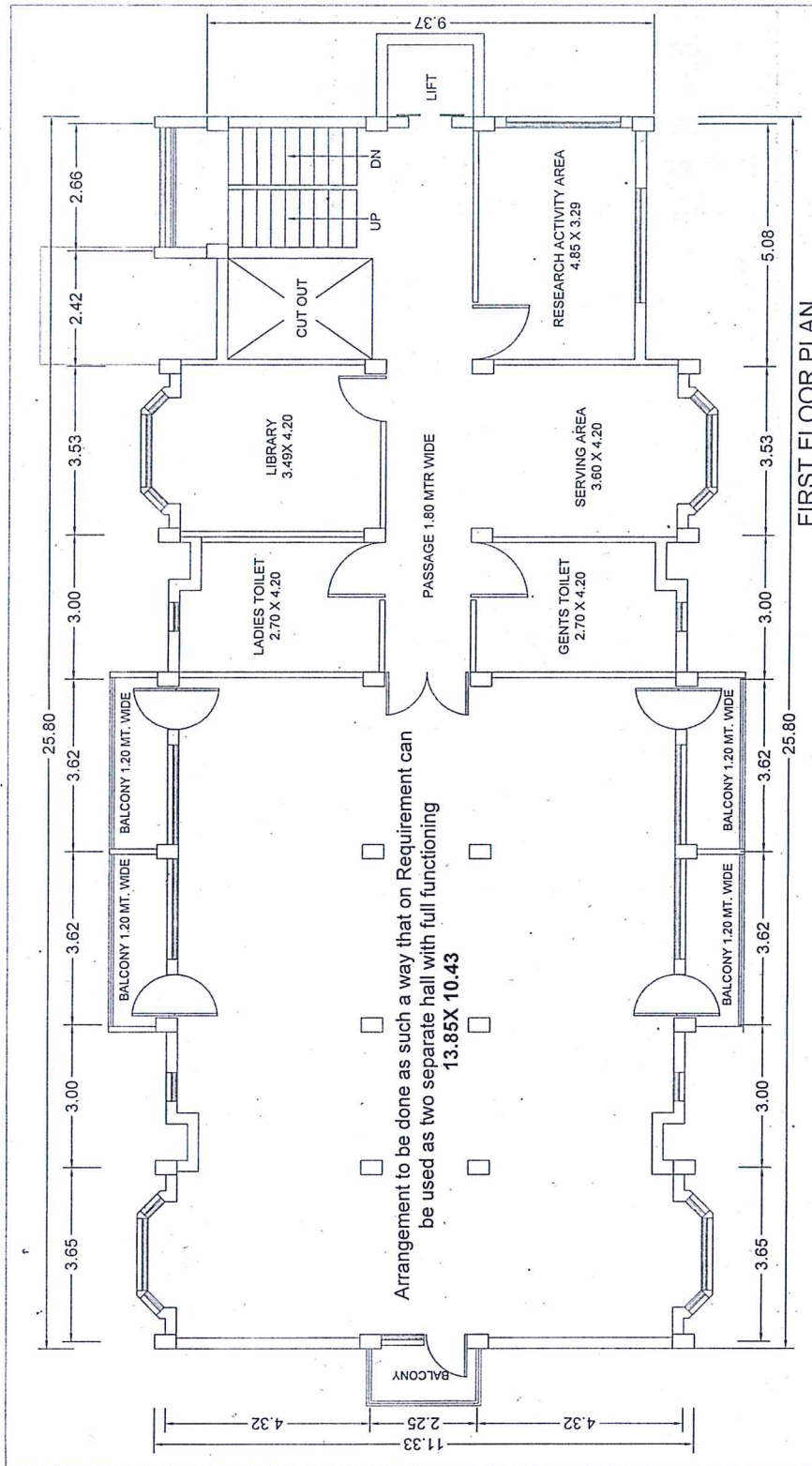

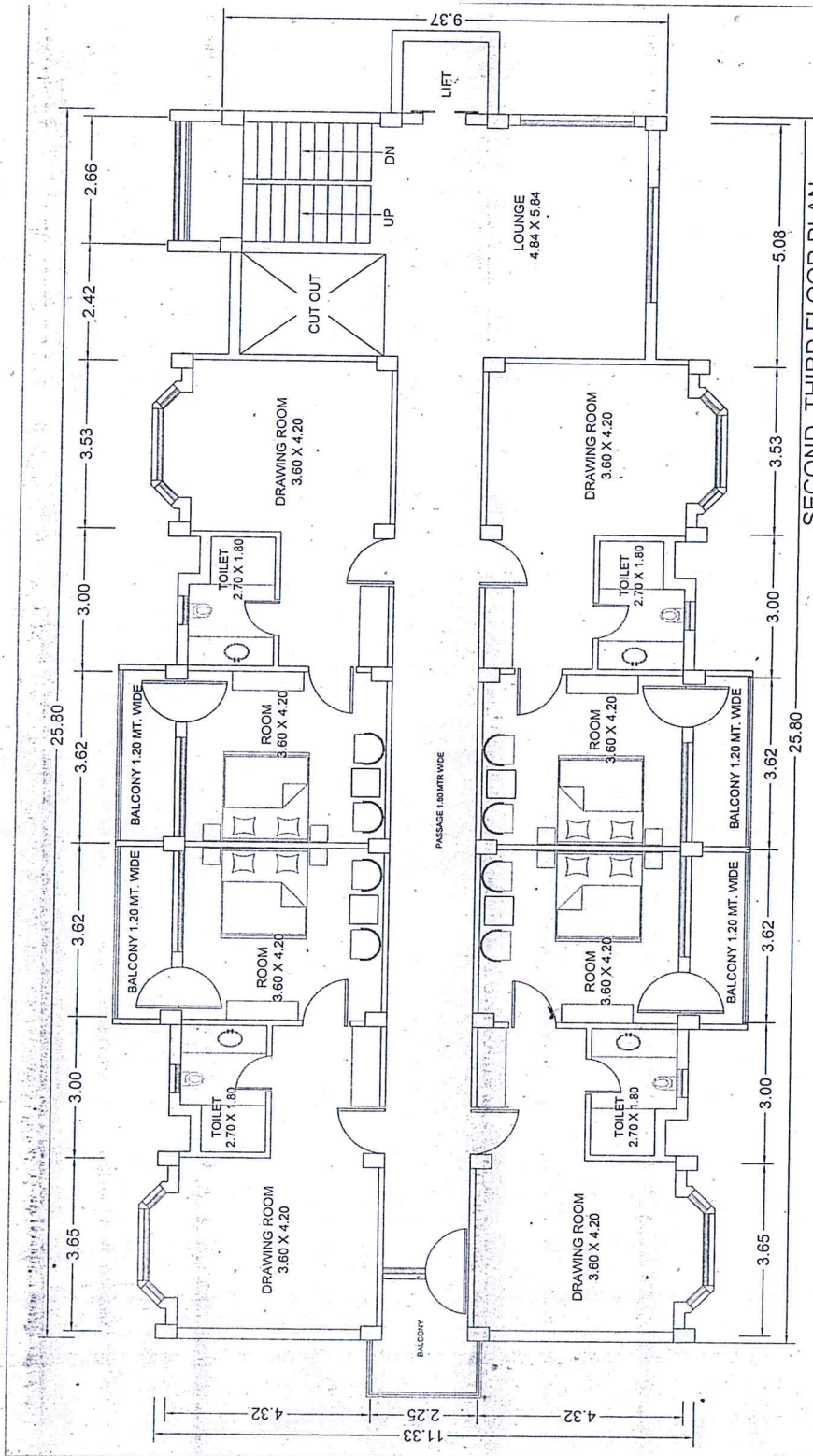
CONTOUR PLAN OF GUEST HOUSE FOR BANARAS HINDU UNIVERSITY, SHIMLA

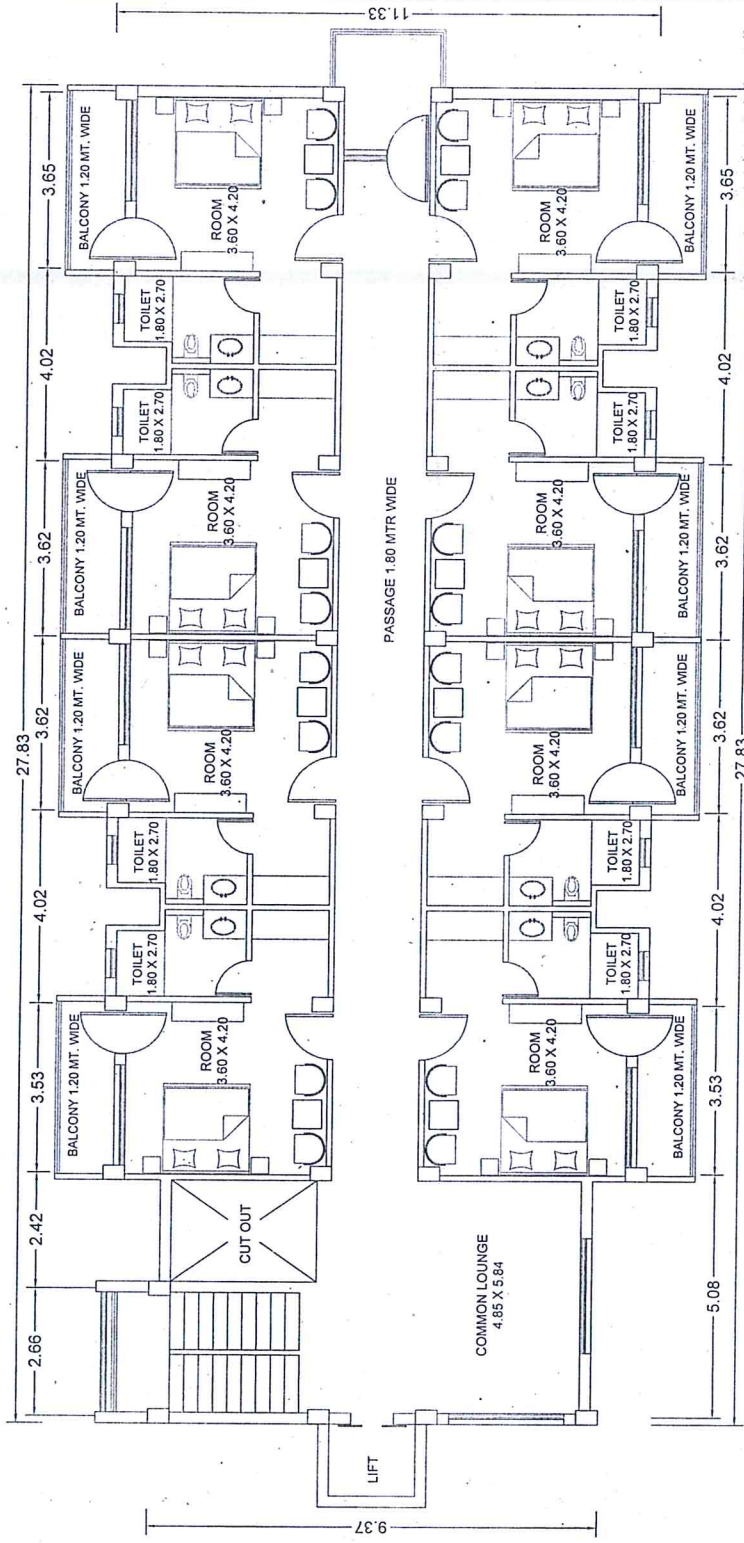
FIRST FLOOR PLAN

TO CONSIDER the work performance and achievements, report of Centenary Chair Professors in Bharat Adhayayan Kendra in terms of ECR No. 223 dated November 1-2, 2020 for extension of their appointment on Centennial Chairs in Bharat Adhyayan Kendra for a further period of one year i.e. up to completion of five years as per terms of the Chairs.

NOTE

A Scheme of appointment of Centennial Chair Professor in Bharat Adhyayan Kendra for a period of five years was approved by the Executive Council. Accordingly, the Executive Council in its meeting held on November 7, 2016 has been pleased to appoint Prof. Kamlesh Dutt Tripathi, Prof. Yugal Kishore Mishra and Prof. Rakesh Kumar Upadhyay on the Chair on an honorarium of Rs.1,00,000/- per month initially for a period of one year and extendable up to five years after assessment as per terms of the Chairs.

The Executive Council vide its Resolution No.482 dated 26.09.2017 agreed to the proposal of the Vice-Chancellor for continuity of persons appointed on Chairs and resolved that the appointment made on the Centennial Chairs in Bharat Adhyayan Kendra be extended for a further period of three years. According to which the terms of appointment of persons on Centennial Chairs in Bharat Adhyayan Kendra is going to complete four years in November — December 2020.

Prof. Rakesh Kumar Upadhyay vide his letter No.BAK/2020-21/32 dated 29.09.2020 has requested for extension of appointment for a further period of another one year as per the terms of appointment i.e. up to five years. Further in his letter, request has also been made by him for extending medical facility to the self and dependents of the chair.

The matter was placed before Executive Council for its consideration and the Executive Council vide ECR No. 223 dated November 1-2, 2020 resolved as under:

RESOLVED THAT a report on the work performance and achievements by the Centenary Professors in the centre alongwith its future plans be put up before the Executive Council.

Accordingly, the work performance report has been submitted by Prof. Rakesh Kumar Upadhyay which has been duly endorsed by the Co-ordinator vide his email dated 03.06.2021. 

This is continuation to my earlier mail today I would like to submit that -

1. Prof Kamalesh Datta Tripathi, CCP, BAK proposed to undertake the work of editing Natyashastra of Bharatmuni (36 Chapters) translated by late Pt. Madhusudan Shastri, published by BHU in three volumes along with the translation of its last few chapters. The work is in progress. 8 Chapters are composed in BAK and have been given to Prof. Tripathi for editing.

2. Prof. Yugal Kishore Mishra, CCP, BAK proposed to undertake translation of Second Chapter of Rigveda Pratishakhya, The Hindi Translation of the same has been completed in November 2020 as per the written information received from Prof. Mishra.

3. Prof. Rakesh Kumar Upadhyaya, CCP, BAK has already submitted details of his academic contribution earlier attached and again attached herewith. Further in addition to these academic works the Centenary Chair Professors have been assisting in the planning and execution of academic activities of the BAK including special lectures, seminars, workshops, monograph writing by the Centenary Visiting Fellows (CVF). They have been guiding the CVFs in the preparation of MA in Hindu Studies two year regular course syllabus of BAK which is completed in January 2020 and is approved by the University for introduction from the forthcoming academic session.
