- (ii) Must be registered with the Central/State Medical Council.
- (iii) A Postgraduate degree (MD/MS/DNB) in the specialty concerned, from a MCI recognized college / institute.
- (iv) For Senior Residency in Cardiology, Endocrinology, Gastroenterology, Nephrology, Neurology, the postgraduate qualification will be MD/DNB in General Medicine
- (v) For Senior Residency in Geriatric Medicine, the postgraduate qualification will be MD/DNB in General Medicine / Geriatric Medicine
- (vi) For Senior Residency in Neurosurgery, Pediatric Surgery, Plastic Surgery and Urology, the postgraduate qualification will be MS/DNB in General Surgery

(B)FOR SENIOR RESIDENTS IN THE FACULTY OF DENTAL SCIENCES:

- (i) A recognized Dental qualification included in the Part-I or Part-III of the Schedule Dentist Act, 1948 (persons possessing qualification included in the Part-I or Part-III of schedule should also fulfill the conditions specified in sub-section (1) and (2) or (4) of Section 10 of the Dentist Act, 1948).
- (ii) Must be registered with the Central/State Dental Council.
- (iii) A Postgraduate degree (MDS) in the concerned specialty from an DCI recognized college / institute.

(C) FOR SENIOR RESIDENTS IN THE FACULTY OF AYURVEDA: -

- (i) A recognized graduate qualification in Ayurveda (**BAMS**)
- (ii) Must be registered with the CCIM.
- (iii) A Postgraduate degree (MD/MS Ayurveda) in concerned specialty recognized by CCIM

6. <u>TERMS AND CONDITIONS:</u>

(i) The number of vacancies is provisional and may vary. Institute reserves the right to change the number of vacancies.

- (ii) Incomplete applications will not be considered, and no correspondence will be entertained in this matter. All particulars in the application form must be entered carefully. All claims made in the application must be supported with documentary proof.
- (iii) A candidate can apply for the post of Sr. Resident, as the case may be, *in ONE*

<u>DEPARTMENT only</u>. However, if a candidate is having eligibility for a post in more than one department and is willing to apply for all the posts in all such departments, he/she will have to apply separately for posts in each department.

- (iv) Candidates who have completed three years' tenure of Senior Residency in a particular discipline or have done DM/ M.Ch. are not eligible for the post of Senior Resident. (*ΠThose candidates who* have three years teaching experience in the subject as Resident/Registrar/Demonstrator /Tutor/or work experience gained during DNB training in both Broad Specialities and Super-Specialties course in other locations/institutions (100 or more bedded hospitals) are also <u>eligible for One Year Senior Residency</u> in the Superspeciality Departments of Faculty of Medicine[]).
- (v) The postgraduate degree [MD/MS/MDS/MD(Ay)/MS(Ay)] must be from a MCI/NMC/CCIM recognized institution. Candidates must show postgraduation degree passing certificate on the day of interview.
- (vi) Candidate applying for these posts should attach self-attested Photocopies, certificates/ documents in support of educational qualification(s), experience, age/date of birth certificate, MCI/DCI/CCIM registration certificate, category/Community certificate, Fresh OBC certificate, and NOC from the present employer (if employed) at the time of document verification. At the time of document verification, these candidates will also be required to produce all Original Documents in support of the documents, failing which their candidature for further recruitment process will be cancelled.
- (vii) No request for a change of category applied for shall be entertained after submission of the application.
- (viii) The candidates claiming reservation under EWS category, should submit "Income & Asset Certificate applicable for Economically Weaker Section" as per Office Memorandum no. 36039/2019-Estt (Res), Dated 31.01.2019 of Government of India
- (ix) List of eligible candidates for appearing in the Interview will be available, approximately one week before the date of Interview on the IMS, BHU website.
- (x) If ineligibility is detected at any stage, candidature/selection of the candidate will be cancelled/terminated without any notice.
- (xi) Candidates should report for interview on scheduled date at 9:00 AM in the IMS directorate along with original documents.

- (xii) No TA/DA is admissible to the candidates for appearing in the interview and document verification.
- (xiii) The result will be declared only on the Institute's Website: <u>www.bhu.ac.in</u> OR <u>https://new.bhu.ac.in/</u> No individual information at any stage shall be sent to any candidate and hence all candidates should regularly visit the Institute's website for information/update in this regard.
- (xiv) Private practice in any form during the tenure of residency is prohibited. The period of residency is strictly full time and continuous.
- (xv) The appointment against above vacancies is purely on temporary basis for a period of one year at the first instance, extendable up to three years subject to satisfactory performance.
- (xvi) The rules are subject to change in accordance with the decision of the Institute as taken from time to time.
- (xvii) If a candidate gets appointment on the basis of false claim of Reservation, his/her services shall be terminated without assigning any further reasons and without prejudice to such further action as may be taken under provisions of the Indian Penal Code of fake/ false certificate. Candidates may also note in respect of the above that their candidature will remain provisional till the veracity of the concerned document is verified by the Appointing Authority.
- (xviii)In case of any inadvertent error in the process of selection which may be detected at any stage even after the issue of appointment letter, the University reserves right to modify/withdraw/cancel any communication made to the candidate.
- (xix) In case of any dispute / ambiguity that may occur in the process of selection, the decision of the University shall be final
- (xx) Dispute, if any, in regard to any matter referred herein shall be subject to the jurisdiction of Varanasi alone.

7. CRITERIA FOR AVAILING RESERVATION FOR AN ECONOMICALLY WEAKER SECTION (EWS):

The candidates seeking reservation under EWS should fulfill the criteria as prescribed by Government of India (*Office Memorandum F.No.36039/1/2019 dated 31st January 2019 by Ministry of Personnel, Public* Grievances & Pension, *Government of India*) and not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below Rs. 8.00 lakh (Rupees eight lakh only) are to be identified as EWSs for benefit of reservation. Income shall also include income from all sources i.e., salary, agriculture, business, profession etc. for the financial year prior to the year of application. Also, persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income: -

a. 5 acres of agricultural land and above;

- b. Residential flat of 1000 sq. ft. and above;
- c. Residential plot of 100 sq. yards and above in notified municipalities;
- d. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.

The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years.

The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authorities in the prescribed format as given in Annexure-III shall only be accepted as proof of candidate's claim as belonging to EWS: -

- a) District Magistrate/Additional District Magistrate/ Collector/ Deputy Commissioner/Additional' Deputy Commissioner/ 1st Class Stipendiary Magistrate/ Sub-Divisional Magistrate/ Taluka
- b) Magistrate! Executive Magistrate/ Extra Assistant Commissioner
- c) Chief Presidency Magistrate/Additional Chief Presidency Magistrate/
- d) Presidency Magistrate
- e) Revenue Officer not below the rank of Tehsildar and
- f) Sub-Divisional Officer or the area where the candidate and/or his family normally resides.

INCOME & ASSET Certificate must be in the format as mentioned in the **Annexure-III**. The crucial date for submitting the income and asset certificate shall be the closing date for submission of OFFLINE applications. If the candidates belong to SC / ST / OBC (Central List), they are not eligible to apply under EWS category. The Institute shall verify the veracity of the Income and Asset certificate submitted by the candidate.

A candidate belonging to EWS will not be denied the right to compete for appointment against an unreserved seat. Candidates belonging to EWS who are selected on the basis of merit and not on account of reservation, will not be counted towards the quota EWS for reservation.

Where any vacancy earmarked for EWS cannot be filled up due to nonavailability of a suitable candidate belonging to EWS, such vacancies shall not be carried forward to the next recruitment year as backlog.
