About the Faculty

Postgraduate teaching and research in Ayurveda was initiated with the inception of Postgraduate Institute of Indian Medicine in the year 1963 at Banaras Hindu University, the largest residential University in Asia and spread over an area of 16.5 sq. km. The Banaras Hindu University, established in 1916 by Mahamana Pt. Madan Mohan Malaviya Ji, is one of the prestigious Central Universities of the country. This University is an autonomous institution and repute having the Hon'ble President of India as its visitor. Being a living embodiment of such visionaries as Pt. Madan Mohan Malaviya, Dr. Annie Besant and Dr. Radha Krishnan, its national Institution epitomizes a synthesis of ancient wisdom and modem scientific temper. The University has 127 teaching departments, many of them recognized as centers of excellence, 14 faculties and 4 institutes viz. Institute of Medical Sciences, Institute of Agricultural Sciences, institute of Management study and Institute of Environment & Sustainable Development along with Indian Institute of Technology BHU with the unique distinction of having them in a walled campus.

The Institute of Medical Sciences is the first of its kind in the country, comprising of Faculty of Ayurveda, Faculty of Dental Sciences and Faculty of Medicine under one umbrella real synthesis of ancient wisdom and modern scientific temper in the field of medical sciences.

Various departmental under the Faculty of Ayurveda also runs two years PG diploma courses in: Agni Karma avam Jalaukavacharan, Sangyaharan, Panchakarma Therapy, Maternal Health Care, Neonatal and Child care, Kshar Karma, Vikiran and Chhaya, Ayurvedic Pharmaceutics as well as one year certificate course in Prasava Vigyan and Ayurvedic Pain Management.

The Institute has a well equipped library containing nearly 1, 00,000 volumes of reading materials i.e. in the form of books, journals, technical reports, manuscripts etc. and subscribes more than 200 national and international journals. It also has photo copying & internet facility and computer based MEDLARS data base on CD-ROM from 1996.

There is a separate wing of Ayurvedic hospital with 180 indoor beds and outdoor facilities for Postgraduate teaching and research activities apart from another wing of teaching hospital with nearly 900 beds strength with all kind of sophisticated and diagnostic equipments. The Faculty departments have all such facilities to impart both basic and advanced knowledge of Ayurveda along with integrated approach in the field of medical sciences. It also provides ample opportunities for fruitful interaction to the Postgraduates and teaching staff of various disciplines.

2. ELIGIBILITY:

- 2.1 The candidate holding BAMS or equivalent degree recognized by BHU and CCIM.
- 2.2 The candidate should have passed I.Sc. (Biology) or equivalent examination recognized by BHU.
- 2.3 All the candidates must have qualified with Sanskrit as one of the subjects in Intermediate or equivalent examination or as a part of BAMS examination recognized by Banaras Hindu University.
- 2.4 The candidate must have completed minimum 12 months Internship (4 ½ years BAMS Course) / 6 months Internship (5 years BAMS Course) by 30.6.2018 after passing the final professional examination.
- 2.5 There is no maximum age limit for candidates.
- 2.6 Registration as medical practitioner is essential.

3. REGISTRATION FORMS:

- 3.1 The REGISTRATION form can be Downloaded from I.M.S. websites www.bhu.ac.in/ims/ The candidate has to email the filled up form to hodkbdchay2018@gmail.com .
- 3.2 Registration Fee: Rs 500/-

Mode of Payment: by Demand Draft of any Nationalized bank by speed post with print copy of downloaded Registration form at address of office of Head: 'The Head, Department of Kaumarbhritya/Balroga, Faculty of Ayurveda, I.M.S., B.H.U., Varanasi 221005'.

- 3.3 In respect of candidates belonging to Schedule Caste or Schedule Tribes Category, a certified true copy / photocopy of a certificate from any one of the following authorities stating that the candidate belongs to a Schedule Caste or Schedule Tribes category, must be produced at the time of counseling.
- (a) District Magistrate / Additional District Magistrate / Collector / Deputy Commissioner / Additional Deputy Commissioner / Deputy Collector / Ist Class Stipendiary Magistrate / City Magistrate / Sub-Divisional Magistrate

Taluka Magistrate / Executive Magistrate / Extra Assistant Commissioner.

- (b) Chief Presidency Magistrate/Additional Chief Presidency Magistrate / Presidency Magistrate. (c) Revenue Officers not below the rank of Tahsildar.
- (d) Sub-Divisional Officer of the area where the candidate and his/or her family normally resides. (c) Administrator/Secretary to Administrator/Development Officer (Lakshadweepa Island).
- 3.4 OBC candidates are required to produce a certificate issued by the competent authority stating that candidate belongs to OBC category of Govt. of India and falls in the non-creamy layer of OBCs. The certificate should be recent one Issued on or after dated 1st February, 2018.

4. SELECTION:

- 4.1 The candidates will be selected for admission based on merit of AIAPGET-2018.
- 4.2 Separate merit list will be prepared amongst all the categories.
- 4.3 In case of equal marks at the test the inter-se-ranking of the candidates shall be determined in the following order -
- (a) Percentage of aggregate of marks obtained by the candidates in BAMS (Final) examination. (b) Total aggregate marks obtained in all the professional examinations (1st to Final year/1st to Final prof.).
- (c) Number of failures during the course of undergraduate studies (BAMS).
- (d) Percentage of Marks obtained in I.Sc. or equivalent examination.
- (e) If the marks at the above also happen to be the same, the date of birth would be the basis i.e. the candidate senior in the age would rank higher.
- 4.4 Roll number of AIAPGET-2018 is mandatory to mention in the downloaded Registration form and Admit card of AIAPGET-2018 is to be presented at the time of counseling. Selected candidates will have to appear before the admission committee for counseling.

5. IMPORTANT NOTES:

- 5.1 Selected candidates will have to execute a bond on non-judicial stamp paper of Rs.100/- (to be purchased from Varanasi or any district of State of Uttar Pradesh only) at the time of joining the course.
- 5.2 Private practice of any kind shall not be permissible during the entire duration of the course.
- 5.3 The admission and continuance of Registration/Residency of the candidate shall be subject to the BHU Act, Statutes, Ordinance, Rules and Regulations and orders as may be applicable from time to time and the aforesaid bond. The registration / admission may be cancelled without any notice if supervisor /HOD is not satisfied with the work and /or conduct of the candidate.
- 5.4 If it is detected that there is something against the candidate which would have prevented him/her from being admitted to the institute for providing false information or fake documents, act of gross misconduct and indiscipline, his/her candidature for admission to the Two years P.G. Diploma course in Kaumarbhritya shall not be considered and his/her provisional admission shall be liable to be cancelled.
- 5.5 The decision of the admission committee of Department of Kaumarbhritya Faculty of Ayurveda, Institute of Medical Sciences, BHU, shall be final and binding on the candidate in respect of the admission to the postgraduate Diploma course.
- 5.6 Fee paid for Registration is not refundable/transferable or reserved for future.
- 5.7 In case of any dispute the decision of the admission committee shall be final. However, an appeal may lie to the Vice-Chancellor, Banaras Hindu University, against such decision. In no case any candidate shall take recourse to the court of law directly.
- 5.8 In case of any dispute Varanasi shall be the jurisdiction or High Court of Allahabad.
- 5.9 Candidates will have to bring admit card (original) of AIAPGET-2018, all original certificates, Marks sheets and Internship completion certificate, caste certificate (for SC/ST/OBC non creamy layer candidate) and PC certificate at the time of the counseling and have to submit documentary proof at the time of Admission that their degrees are recognized by CCIM.
- 5.10 The provisional eligibility of the candidates to appear at the Counseling is ordinarily decided on the basis of merit of AIAPGGET2018. The candidates shall be debarred from appearing at the Counseling, if candidate is found ineligible or have submitted wrong information. If the information submitted is found wrong at the time of counseling or even later, such candidates shall have no claim for admission to the courses and if admitted the admission shall be cancelled.
- 5.11 Mere submission of application, appearing at the counseling and qualifying will not entitle the candidate to claim admission in the P.G. Diploma course.
- 5.12 The candidates appearing in the counseling will have to make their own arrangements for stay at Varanasi.
- 5.13 No TA/DA will be paid to the candidates for appearing in the counseling or for joining the course.

Department of Kaumarbhritya/Balroga

The Kaumarbhritya/Balroga, had its seed sown from the day of inception of dep't of Prasuti Tantra, in erstwhile PGIIM, college of medical sciences, BHU. By 1974, its academic, research and hospital services activities expanded so much. It attained the status of an academic unit with Dr C. Chaturvedi as in charge. Considering the quantum of output of the unit, its socio-medical need and scope of work, the University administration made it as an independent unit academically and administratively both (vide Executive Council Resolution no. 34, dated 15. 06.1980). In 2006, Department of Kaumarbhritya / Balaroga was established, independently.

With the passage of time Prof. C. Chaturvedi retired and Dr R.D. Sharma took over as in charge, Kaumarbhritya unit in 1993. Subsequently, Dr. B.M. Singh became the first head of the department from its inception i.e. 2006 and continuing till date with an interlude of 1 ½ year.

The department is conducting research, providing teaching- training of Kaumarbhritya subject, day to day paediatric & neonatal care with well equipped NICU and also inculcating knowledge of other concerned science subjects to MD (Ay), PhD, PGDNC (Ay) and D.Ch. (Ay) [Diploma in Paediatrics (Ay)] and undergraduate students i.e. BAMS.

The department has introduced new special courses PGDNC (Ay) in 2007, CCIM recognized post graduate diploma course-D.Ch. (Ay) in 2014 for the medical graduates. As well as a certificate course on Balpanchkarma attendant, in 2018 first time in India and abroad.

The objectives of Kaumarbhritya Department are to develop a specific pattern of teaching and training for the undergraduate and postgraduate students as well as enable them for treating almost all paediatrics disorders including life threatening conditions more rationally by applying basics concepts & drugs of Ayurveda, additional to getting exposure to knowledge of modern medical sciences.

Available Facilities

A) Department

a. Teaching and training to the BAMS, MD (Ay) and PGDNC (Ay), D.Ch (Ay) students are given via audio-visual presentation, chalk-board (traditional) in the class, bedside demonstration, live demonstration and practice training by skilled faculty members. Students are encouraged for preparing research papers, to attend & presentation of paper in the seminar/workshops, facilitate for the training like BALS, PALS etc as well as participation in various national programmes.


- b. Research work: It is carried out by the MD (Ay), PhD scholars under the guidance of teaching faculty of the department in assistance with department of Paediatrics, faculty of management studies, IIT-BHU and other Faculty/departments of the University as and when needed.
- c. Basic Lab Facility: To provide training for routine investigation and for research work, departmental lab has basic lab facilities for the students and research scholars.
- d. Library Facility is available for the MD (Ay), PGDNC (Ay), D.Ch. (Ay), PhD scholars and faculty members of the department. Library also has printing and Xerox facility.
- e. Internet Facility and Wi- Fi Facilities.
- B) Hospital: NICU (up to 26 wks and 670 gm. preterm babies have survived, Rooming-in and Bala-panchakarma facility are available in hospital. NICU/Kashyapa ward has been enriched with CNS (Central Nursing Station) facility. The purpose is to have the vigilant and excellent monitoring of sick neonates and children admitted in the ward and NICU.
 - a. Paediatric and NICU Procedures: Exchange blood transfusion, photo therapy, bone marrow aspiration, lumber puncture, thoracocentesis etc. Providing successful treatment in cerebral palsy (during the infantile period), mild to moderate bronchial asthma, post meningeal sequel etc.
 - b. Pediaric Panchkarma Procedures: Snehan, Swedan, Shirodhara, Shiro-abhyanga, Shiropichu, Avagahan, Nadiswedan, Vasti, Nasya Karma etc. in cerebral palsy, DMD, post meningeal sequel, ADHD etc.
 - c. Immunisation and Lehan Karma (Tuesday and Saturday in each week).
 - d. Prakriti-vikriti Assessment Lab: Prakriti abersment and parents counselling, data recording facility is available.
 - e. Internet Facility and Wi Fi Facilities.
