DRUG SHOP AT TRAUMA CENTRE

Terms & Conditions

- Shop will run 24 hours
- Proper receipt have to be given to the patient on site.
- Initial contract is for 1 year only which will be reviewed after every year.
- Shop will be frequently checked and verified by the committee appointed by appropriate authority.
- Monthly rent will be Rs.15.00 lakh which will be reviewed on yearly basis.
- The staff employed in the Pharmacy should be certified and permitted by the hospital authorities and only qualified person shall be employed.
- Electricity charges for running the Drug Shop shall be on payment basis as per actual consumption shown by the sub-meter and water charges will be fixed by the BHU.
- The space provided for Drug shop is situated in the Trauma Centre premises but the security of the space will be provided by the Vendor himself. The BHU shall not be liable for any loss or damage to the property of the shop arising due to theft, fire etc. or otherwise.
- The BHU shall not be liable for any misconduct or misbehavior of any employee of the shop towards the consumers/customers of the Drug Shop.
- Earnest money of Rs.15.00 lakh will be deposited in favour of The Registrar, BHU payable at Varanasi.
- The electrical fittings, interior work and all furniture and fixture will be done by the vendor at its own cost in the space provided by the BHU.
- All the payments payable by the Vendor such as Rent, Electricity and Water charges will be made within 07 days of the succeeding month along with statement of expenditure, failing which the BHU shall be liable to pay interest on the due amounts @ 12%. However, if the payments are not made within two months, the license shall stand revoked and the licensor shall have the right to evict the Licensee and disconnect the supply of electricity and water to the building.
- Criteria for allotment
 - The firms which will give maximum discount on MRP to the patients as per details.
 - (a) On tablet/capsule/injection
 - (b) On fluid/drip material
 - (c) On surgical items/appliances/kits
- The proper MoU will be signed at the time of allotment having silent features which will be legally bound on both the parties
- Other terms and Condition has to be accepted as laid down by the University and Hospital Administration.
