## **NOTIFICATION**

In continuation to the Office Order no. R/GAD/Misc.-Covid-19/Misc.-45/59188 Dated-18 March, 2020. It is for kind information of all concerned that as per the guidelines received from UGC/MHRD, no academic activities other than online mode is expected to commence before  $1^{\rm st}$  July, 2020, in view of which it has been decided that as the public transport facilities have been relaxed for essential movements during lockdown 4.0, those students who were unable to travel to their hometown after March  $23^{\rm rd}$  and are still residing in the hostels shall vacate the hostel within 48 hours.

For safe transportation of the students from BHU to their hometown necessary permission/passes have been obtained for the students from the District Administration and buses have been arranged for the purpose by the University. These students will be sent to their home by these buses following the necessary safe guards.

Therefore, all the students who are presently residing in various hostels of the University are hereby requested to report to the Chief Proctor office immediately for their transportation information and needful guidelines and co-operate with the Chief Proctor and their Adminstrative Wardens/Wardens in this regard.
