NOTIFICATION

It is notified that consequent upon the assent of the President of India to "The Institutes of Technology (Amendment) Act, 2012", Ministry of Law and Justice (Legislative Department), Government of India Published the said Act in the official Gazette of India dated June 21, 2012. Subsequently, in exercise of powers conferred by sub-section (2) of Section 1 of the said Act, the Government of India, Ministry of Human Resource Development (Department of Higher Education) vide its Notification dated 29th June, 2012 has appointed 29th day of June, 2012 as the date on which the provisions of the said Act shall come into force, thereby converting the erstwhile Institute of Technology, B.H.U. as "The Indian Institute of Technology (Banaras Hindu University), Varanasi".

Consequent upon conversion of the Institute of Technology, Banaras Hindu University as "The Indian Institute of Technology (Banaras Hindu University), Varanasi", the relevant provisions of Statute 3.A, 22, 23, 25A, 25A(5), 27, 60 and 25(1) (List of Departments in Banaras Hindu University), stand repealed with effect from 29th June, 2012 that is the date appointed by the Government of India for commencement of "The Institutes of Technology (Amendment) Act, 2012". The said repeal/amendment in Statutes of Banaras Hindu University is in accordance with the recommendations of the Executive Council vide ECR No.156 dated April 15, 2010, duly approved by the President of India, in her capacity as the Visitor of Banaras Hindu University, in exercise of the powers conferred under Section 17 of the BHU Act, and communicated by the Ministry of Human Resource Development (Department of Higher Education), New Delhi vide letter No. F.1-11/10-Desk (U) dated 16th December, 2010.



I am directed to inform you that in exercise of powers vested in her under the BHU Act the President of India in her capacity as the Visitor of Banaras Hindu University, has been pleased to assent to the following addition to Statute 10 relating to the Court of Banaras Hindu University as passed by the Executive Council of the University vide ECR no.98 dated 6.10.2009:

(4) The Annual report of the University shall be submitted to the court in its annual meeting to be held latest by Middle of November every year.

Accordingly, the Statute 10 relating to the Court of Banaras Hindu University printed at page 31 of the BHU Calendar Part-I Vol. I, 1983 and amended vide ECR no.33 dated July 19-20, 2002 has been amended to read as under:-

10(1) *The Court shall consist of the following members namely:-*

- (a) *the Chancellor, ex officio*
 - (b) *the members of the Executive Council, ex-officio*
 - (c) *three persons being Heads of Departments of Studies or Principals of Colleges of the University, nominated by the Visitor,*
 - (d) *two persons being Professors from Departments of Studies or Colleges of the University, nominated by the Visitor*
 - (e) *two persons from among teachers of the University, other than Professors, nominated by the Visitor*
 - (f) *three representatives of Parliament, two to be nominated by the Speaker of the Lok Sabha from among the members thereof and one to be nominated by the Chairman of the Rajya Sabha from among the members thereof, provided that consequent on a member of Parliament becoming a Minister or Speaker/Deputy Speaker, Lok Sabha or Dy.Chairman, Rajya Sabha, his/her nomination/election of the statutory body shall be deemed to have been terminated and;*
 - (g) *thirty persons nominated by the Visitor from among persons who are men of standing in public life or have special knowledge or practical experience in education or have rendered eminent services in the cause of education*
- (2) *Seventeen members of the Court shall form the quorum*
 - (3) *All members of the Court, other than ex-officio members shall hold office for a term of three years.*
 - (4) *The Annual report of the University shall be submitted to the court in its annual meeting to be held latest by Middle of November every year.*


