NOTIFICATION

In terms of letter D.O.No.1-1/2013/GBC dated 03rd June, 2013 of Economic Advisor (HE), Ministry of HRD, Deptt. of Higher Education, Govt. of India, New Delhi alongwith D.O. No. 281/3/1/2013-TS, dated 30th January, 2013 of Cabinet Secretary, New Delhi, the Vice-Chancellor has been pleased to approve the following Road-map for the guidance of members of the University to tackle the menace of Sexual Crime against women:

1. At the beginning of the session Orientation Programme for Boys and Girls can be conducted to educate the students of the rules, guidelines and law pertaining to women-related issue. The programme may widely cover areas governing the conduct, especially moral and ethical related teachings can be also incorporated.
2. Immediately after admission a mandatory training of 3-6 months of Martial Arts/Self Defense for girls (3 to 6 months) can be arranged.
3. All the faculties and departments can be kept well informed and made aware of all updates regarding the security arrangements for the girls students at the University.
Posters displaying the existence of Women Cell with helpline numbers can be displayed at public places, hostels/departments.
4. At least two Seminars and Workshops can be held every session on issues related to Women Rights/ Empowerment, Safety and Health, with special reference to gender equality and sensitization.
5. In order to avoid offensive environment for women at work place, the internet access to all pornographic material can be curbed.
6. Strong action be taken to ward off offending employees which would act as deterrent to others.
7. Hostel timings and by- laws of the hostels to be reframed with special reference to various levels of security being extended to the girl students of different courses in UG, PG and Research.

All concerned are requested to take necessary action accordingly.
