NOTIFICATION

It has been observed that students and others of the University community have been staging **Dharna** on the University campus, at times, even in front of the residence of the Vice-Chancellor causing disruption in the congenial teaching-learning environment of the University. Further, as Institute of Medical Sciences and its Hospital render essential patient care services, their uninterrupt, smooth and peaceful functioning is vitally important. Staging **Dharna** on the campus is neither legitimate nor justified on any account.

Attention of students is invited to the following provisions of B.H.U. Calendar Part-II, Volume-II (Pages 345-347) according to which *No student of the University shall indulge in an act of indiscipline which includes*:

 Organizing of a procession or meeting without the permission of the appropriate authority or participation therein;

An act which hampers, whether through pressure or threats or other improper way, the discharge of duties or exercise of free discretion where-ever vested by persons entrusted with the task of performing such duties or

exercising of such discretion;

 Participate in any activities such as gherao, camping inside the boundaries of houses of teachers or officers, use of derogatory slogans, abuses and propaganda to incite hatred violence, preparation for and resort to violence or destruction of property;

An act which disrupts the smooth running of the University or environment conducive to the pursuit of knowledge of harmonious relationship between

different peoples living in the Campus ;

An act attempting to commit an act of indiscipline, abetting an act of indiscipline inciting others to commit an act of indiscipline or causing others to do an act of indiscipline, individually or in combination with others :

 Disrupt teaching, study, examination, research or administrative work, cocurricular or extracurricular activity or prevent any member of the University and its staff from carrying on his work, or do any act reasonably like to cause such disruption or prevention, such as locking of Offices or any other building,

Similar provisions exist in the CCS Conduct Rules, 1964 applicable of employees of the University.

Accordingly, no student/employee shall indulge in any demonstration, which is prejudicial to the interests of the University, public order, decency or morality, or which involves contempt of court, defamation or incitement to an offence. Any act or omission putting or amounting to interruption or hindrance in the working of the University Offices, will be treated as unlawful. Further, resort to or, in any way, abetting any act of indiscipline, illustrated above, shall be dealt with firmly.

It is, therefore, reminded that all concerned should desist from such Aet(s) or omission(s). In case of default or disobedience, necessary stem disciplinary action shall be taken against the concerned.

This issues with the approval of the Vice-Chancellor.
