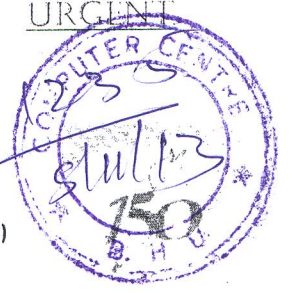

**NOTIFICATION**

It is notified for information of all concerned that the Vice-Chancellor while considering the necessity & sensitivity of continuous running of services of S.S.Hospital and Institute of Medical Sciences, has been pleased to pass orders for observing 6 days week schedule in the Institute of Medical Sciences and Sir Sunderlal Hospital and other faculties attached to the Institute, with immediate effect.

Further, as per orders, the staff of Institute of Medical Sciences and Sir Sunderlal Hospital and other faculties attached to the Institute shall be given 12 days compensatory leave per annum (*in addition to the limit of 30 days compensatory leave to be accumulated as per rules*) as a special case (*in lieu of curtailed list of holidays notified vide No.R/GAD/Misc/50(Holidays)/14224 dated 28.06.2013*) provided that 12 days compensatory leave so given must be availed by the employees concerned during the respective year and shall not be carried forward for next year in any way.
