### **NOTIFICATION**

Applications in the prescribed format are invited from the eligible Professors/Associate Professor/Assistant Professor of the University satisfying/meeting eligibility conditions laid down in the **University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018** for consideration of **promotion under Career Advancement Scheme (CAS)** as per the stages mentioned in the UGC Regulations.

The teachers of the University who consider themselves eligible for promotion under CAS as per aforesaid UGC Regulations are required to submit their application with duly filled in the prescribed proforma available at our website [www.bhu.ac.in/rac](http://www.bhu.ac.in/rac) alongwith relevant documents (**five sets for Senior Professor and one set for others**) for consideration for promotion under CAS to the respective HoDs/Deans/Director/Coordinators/Principal/Faculties/ Institutes/Centres/Schools.

The Directors of the Institutes/Deans of the Faculties/Principal of Mahila Mahavidyalaya/Heads of the Departments/Coordinators of the Schools/ Centres etc. are requested to circulate the Notification amongst the Assistant Professors, Associate Professors, Professors (including those who are on leave) and forward their applications in the prescribed format duly checked and verified about the correctness of the entries recorded therein.

The cases for promotion under Career Advancement Scheme shall be regulated as per the guidelines of the UGC contained in the **University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018**.
