Terms & Conditions:

- 01. The requirement of vehicles is seasonal however the rate offered should be valid for one year.
- 02. The party must be capable of providing Sumo/Bolero/Tavera/Xylo numbering maximum 75 on any day at a specified time for a few days during the period of examinations, i.e. at the time of conduct of University Examinations and Entrance Tests as per requirement.
- 03. Since the University Entrance Tests are scheduled in two/three shifts on specified dates, rates for use of vehicle for minimum 05 hours in a shift should separately be

- 07. Any person who is in the University service or an employee of this Office should not be made partners to the contract by the contractor directly or indirectly in any manner whatsoever.
- 08. The Office reserves the right to terminate the contract without assigning any reason.
- **09.** Rates may be quoted for local as well as for RGSC South Campus, Barkachha, Mirzapur separately.
- 10. Vehicles provided by the contractor should preferably bear Commercial Taxi Cab Registration Numbers and should have Comprehensive insurance and Drivers so provided with the vehicles shall have commercial LMV Driving License.
- 11. The vehicles should confirm to the Pollution norms prescribed, if any, by the transport Department of the Government.
- 12. Penalty of Rs. 100/- per hour delay will be charged for non-providing of vehicles in time.
- 13. The contractor shall provide vehicles as per requirement of the Office.
- 14. The vehicle and Driver shall remain available all the time as per Duty Roster and shall not leave place of duty without prior permission. All the drivers shall carry a mobile for communication to be provided by the contractor.
- 15. Operation and function of vehicles and Drivers shall be governed by Motor Vehicles Act/Motor Vehicles Rules and these shall be the responsibility of the contractor.
- 16. The dead mileage in any case should not be more than 10 Kms. both ways.
- 17. No advance payment will be made.
- 18. Duty Slips/Movement Slips will be signed by the officer with whom the vehicles are attached for duty on day to day basis. No duty slip shall be entertained unless and until the same is certified/verified by the officer concerned.
- 19. The Office reserves the right to vary the numbers of vehicles to be hired.
- 20. The prospective bidder shall furnish the following documents along with their quotation.


