- 11. The Financial bid (price bid) i.e. Bill of Quantity (BOQ) of only technically qualified bidders will be considered by the committee and the result will be displayed on the <a href="www.eprocure.gov.in">www.eprocure.gov.in</a>which can be seen by all bidders who have participated in the tender.
- 12.
