Subject: Modification in Purchase Procedures point 7 (v.) of the BHU Project Gudelines-2018.

Sir/Madam,

The Hon'ble Vice-Chancellor has been pleased to pass order for partial modification in Purchase Procedures point 7 (v.) of the BHU Project Gudelines-2018, in accordance with the chapter-6 rule 155 of GFR, 2017.

The sentence "Minimum three quotations should be called and the purchase be done after technical/financial comparison" in point 7(v.), be replaced with the following sentence – "The Purchase of goods costing above Rs.25, 000/- and up to Rs.2, 50,000/- be made as per Rule 155 of General Financial Rules-2017." For ready reference the rule is quoted below;

As per GFR-2017 chapter-6 rule155- Purchase of goods costing above Rs.25000/- (Rs. Twenty five thousand only) and up to Rs.250000/-(Rs. Two lakhs fifty thousand only) on each occasion may be made on the recommendations of a duly constituted Local Purchase Committee consisting of three members of on appropriate level as decided by the Head of the Department. The Committee will survey the market to ascertain the reasonableness of rate, quality and specifications and indentify the appropriate supplier. Before recommending placement of the purchase order, the members of committee will jointly record a certificate as under,

"Certified that we members of the purchase committee are jointly and individually satisfied that the goods recommended for purchase are of the requisite specification and quality, priced of the prevailing market rate and the supplier recommended is reliable and competent to supply the goods in question, and it is not debarred by Department of Commerce or Ministry/Department concerned".
